#### AN INTRODUCTION TO THE COUNCIL by William Allen LePar

The Council has often referred to themselves as "spiritual beings." We must remember that this is a very elusive term and means something far greater than what we normally have been taught to understand as "spiritual beings."

In our finite minds we look upon spiritual beings as living beings confined in similar manners as we in the physical, and this is not the case with some levels beyond the physical. But in this expanded description from The Council, we begin to realize that there are levels that we can reach as spiritual beings that far surpass our present concepts.

Respectfully, I submit The Council's own personal description of themselves.

#### THE COUNCIL SPEAKS OF THEMSELVES

After a soul or an entity has accomplished a certain level or degree of perfection, through whatever system that is the ruling belief system of that time, then the individual or the soul or the entity is elevated to a level wherein it is not necessary for reincarnation. Once entering the spiritual realms without the need to reincarnate, a growth period is undergone. Many steps of awareness or many levels of awareness are accomplished, many degrees of elevation, many degrees of perfection until finally the soul, the entity has evolved into a state where there are no levels, no degrees, but begins to expand in love and awareness to the point where there is a total mergence or merging with other beings; where all ideas of limitations, all awarenesses of false limitations, have been done away with; where the person or the soul or the entity begins to realize its true unlimitedness and in that begins to expand greater and greater and greater, interweaving more delicately and more closely with all others and all other things, and in so doing grows closer to the Divine Himself. Once a soul or entity has reached this level, then they are in union with others, total union, yet completely individual, and yet completely united. This soul, this entity has its own personality, yet delicately flows in and out and with other souls but yet maintains its own personality, its own being. The soul, the entity becomes more god-like in that it becomes part of all things, yet maintains its own personality, its own being. Once a soul has reached this level then there is no name, there is no body as you would recognize or understand, but a more complete and unlimited Child of God, one who is so developed that no name could ever describe him. That is the existence we live in, and if you wish to use confining and restricting terminologies as levels, then we souls have to say that is the level we exist in. In all of mankind's history this level has never before spoken in the physical plane.

Even though we refer to ourselves as "spiritual beings," we use such statements only to give all who come to us some idea to relate to or some concept that they can relate to.

#### THE TRANCE PHENOMENON

We believe The Trances of William Allen LePar are the rarest paranormal experiences known to modern man. The only example of a similar phenomenon ended with the death of Edgar Cayce in 1945. The Council's unparalleled revelations, through Mr. LePar's trances, are made available to the public through the SOL Association for Research. His time and efforts are without compensation, and SOL is a non-profit, tax-exempt concern dependent on the commitment of volunteers.

The following is a brief explanation of a Trance, so those without the opportunity to participate have a better understanding of the phenomenon. On the day of a Trance, Mr. LePar remains in a peaceful environment. He consumes little food and The Council recommends his diet include red shellfish. He engages in considerable prayer and meditation throughout the day.

Those participating in a Trance, to question The Council, gather about a half hour before the session for socializing. Nancy LePar, his wife, is always the last to leave her husband before a Trance begins. She sits with him in a separate room as he quiets himself with prayer and meditation. When she enters the room in which the trance is to be conducted, all talking and noise cease. Soon he enters, silent and already in an altered state. With everyone seated and quiet, he enters, removes his slippers and positions himself on the floor.

He wears, as instructed by The Council, loose clothing of all natural fabric. Also, Mr. LePar wears no metal other than a wedding ring and cross. As he rests his head and bare feet on pillows, he maneuvers his body into alignment with magnetic north. Those participating, following instructions from The Council, are to place themselves in a quiet, prayerful state as until this remarkable source begins to speak. There are two distinct time periods in the linking of LePar's spiritual vibrations with those of The Council. The first period concludes with LePar's extremely deep and rapid breathing, a form of hyperventilation. His hands, folded across the abdomen, quiver; his left leg stiffens and his left foot extends. Then, suddenly, silence. It seems almost as if he has stopped breathing. Finally, The Council begins to speak -- slowly at first, repeating the name of the Trance moderator, until the link with the physical world is ready. It usually takes about thirty minutes from the time Mr. LePar lies down until The Council speaks. But on some occasions, for a variety of reasons, it can be as long as 45 minutes.

Once The Council begins to communicate, a Trance usually lasts between ninety minutes and two hours. The Council is offered the opportunity to give the gathering an opening statement, which has always become a segment of information useful for universal spiritual growth. Then, the trances follow a simple question-and-answer format, beginning with written questions and continuing with follow-up questions raised by The Council's comments. At some sessions, there are so many follow-up questions that only the first question asked will be from the list of written questions.

Afterwards, when Mr. LePar awakens, he remembers nothing. His memory is blank from the time his wife leaves him before each session until he awakens at the conclusion of the Trance. He is always physically drained, cold and disoriented. He is helped to a seat, wrapped in an afghan for warmth, and given a slice of bread and a glass of orange juice to help him recover.

We hope you profit from the information in these Trance Library Files. If reading a particular file gives rise to a question, we encourage you to contact us for more information. Thank you.

The Council has told us on many occasions that truth has always been available to mankind from the very beginning. As you read this Trance Library File, you may note similarities to information from other sources. You will also encounter new information. Use what you can use and store away that which is not serviceable at this time, for if you wish to see a dawn tomorrow with its clear blue skies, you must make ready for it now. If you cannot believe that tomorrow will be a better day than today, then it will not be so for you. If you do not carry the light of tomorrow, then where will it come from? If you are presently traveling, you are then in a position to create a better path for your travels tomorrow. The outlook for the children of the Divine is definitely a bright and sunny day. Only you can make the decision as to what your tomorrow will be. We have one distinct advantage over each of you, and that is we have gone through the process of life that you are presently experiencing and in those activities we have learned that one must never narrow their vision down to what they prefer to see, but it is great wisdom when one is willing to look at the total picture, even those segments that one wishes were not there.

Always keep this concept in mind: Use what information you can, and that which you cannot agree with,

put it aside for now. Do not discard it, for you may find it very useful in the future.

1313 that, we will give you the answer you want to hear.

# Reincarnation was discussed on 82-12-03, the 111th Trance. The word "reincarnate" was first found on page 1809, line 450.

438	***: You mentioned earlier in reference to the centaurs and
439	other such beings that "those individuals that have, shall we say,
440	blasphemed against such creation are certainly still paying for
441	such trespasses." The question is: How are they still paying?
442	
443	C: By having to return to the material manifestation in situations
444	that are very, how shall we say, appalling to them. In other words,
445	(***), that they because of their actions would absolutely have to
446	re-enter into the material manifestation, and they then would have
447	to undergo some serious condition.
448	
449	***: A related question, but did those who created the half-man-
450	half-animal creatures reincarnate as those creatures?
451	
452	C: Now, be very clear. There are two types of creations. Do you
453	recall?
454	
455	***: Yes.
456	
457	C: The half-man-half-animal which has the soul; the half-animal-
458	half-man which does not have the soul. Do you understand?
459	
460	***: Yes.
461	
462	C: Those who were responsible for the abuse of nature while the
463	abuse continued or was in process, they would return then as
464	half-man-half-animal in some cases. This does not say that this was
465	the case constantly. Do you understand?
466	
467	***: Yes.

469	C: So that for that duration of time when you had the creature
470	with the soul which was the half-man-half-animal, those who were
471	responsible for such creations and who abused such creations would
472	then experience a lifetime at least under those situations or
473	conditions. Now, be sure you understand, we are talking about that
474	creation with a soul, that is the half-man-half-animal. They did
475	not intermingle with the half-animal-half-man which was the
476	creation without the human soul but was of an animal nature.
477	
478	***: Two questions. One, you mentioned before to the first answer
479	to the other question about tampering with nature, you said that
480	they had to come back in an appalling condition. Would those acts
481	be so horrendous that they would have to come back into a situation
482	so bad that they would almost be guaranteed to come back another time
483	before they overcame their difficulties?
484	
485	C: Play with a hot enough fire and it will take an awful lot of
486	water to put it out. Basically, what we are saying is that the
487	more severe you injure others, the harder it is for you to make the
488	correction, and in some cases it may take many, many lifetimes to
489	correct or make amends for the injustices done. No situation or
490	condition is so isolated that you can be guaranteed that it can be
491	done in one experience, because you must remember the extenuating
492	conditions that are caused by the action. Do you understand?
493	
494	***: Yes. Should I ask my second one now?
495	
496	C: Yes, if you choose.
497	
498	***: Thinking about these individuals who did these things coming
499	back as the creatures that they created, is there sort of an eye-
500	for-an-eye type justice in that? Or is that the idea that you will
501	suffer as much as you caused?
502	

503	C: Guaranteed, you will suffer in a proportion equal to what you
504	have caused. That is an absolute. But, that does not necessarily
505	mean that it will be in the same manner or under the same
506	situation. Does that answer your question sufficiently?
507	
508	***: Yes. Does the fact that we will suffer as much as we caused,
509	whose rule is that? Why is it that way?
510	
511	C: Well, that is the rule that each of you have established within
512	yourself.
513	
514	***: So it is a rule of our own creation then?
515	
516	C: Yes, but it is also the justice of the Divine. You see, these
517	standards come from the very essence of your real being. Do you
518	see? Do you understand?
519	
520	***: What I was getting at was that God didn't direct that.
521	
522	C: No, it is a part of God's very Being, but since you are a part
523	of Him, it is also a part of your own being. It is the nature of God
524	that all things be just and fair and equal. Since you are a part
525	of God, then this applies to you and in your own activities. Do
526	you understand?
527	
528	***: Yes.
529	
530	C: And because this is the situation with you, because you are truly
531	a part of God, a creation of God, then you have deemed in the
532	material manifestation a payment equal to the debt. Do you see?
533	
534	***: Yes.
535	
536	C: That is meeting self. Now, there are times, as we have said
537	before, when a soul can be, well shall we put it this way, just a

538	little too full of zeal, if we may use that term, and they may try
539	to make the road just a little bit harder than what it really calls
540	for. In a situation like this, it will go on for a period of time,
541	then the overall Love of your Father will step in and cease that
542	activity. Do you understand?
543	
544	***: Yes.
545	
546	C: In other words, if you are making your way a little harder than
547	what you deserve to have it or say your zeal, your enthusiasm, is a
548	little too demanding, the Love of this Father will instruct you or
549	protect you from overdoing it. Do you follow?
550	
551	***: Yes.
552	
553	C: So you cannot be indebted or you cannot pay a price higher than
554	what the situation calls for. The only time that you may be
555	required to pay more than what you are indebted for or may have to
556	pay a price when there is no debt at all, is if you fall into a
557	certain situation where it is a condition of service or
558	instruction, a situation of instruction, then those souls will
559	ofttimes pay dear prices or have very unpleasant conditions and
560	situations. Do you follow?
561	
562	***: Yes, I do.
563	
564	C: Do you understand the reasoning of that?
565	
566	***: Yes, I think so.
567	
568	C: It is not for their growth that they undergo that hardship, but
569	it is for the growth of others round and about. Now, do you
570	understand more fully?
571	
572	***: Yes, I do.

573	
574	C: But, since none of you fall into that situation, there is not
575	much to worry there. Very well.
576	
577	***: Can I ask a question about those souls that take these things
578	on?
579	
580	C: Yes.
581	
582	***: Would God intervene for them, so they would not go too far?
583	
584	C: No, if a soul comes into the material manifestation as a
585	service, then the distance or the condition or the situation that
586	that soul must endure will be determined solely by those who must
587	learn from that experience. The quicker they learn, the less
588	suffering. Do you see?
589	
590	***: Not really.
591	C: Suppose a member of your family who had been perfectly normal
592	and healthy were to be involved in a very serious accident where it
593	would demand a great deal of sacrifice on your part and the part of
594	your husband and other members of your family in tending to this
595	soul. Saying, for example, this soul did not have to undergo such an
596	accident and such suffering for their growth, but accepted that
597	condition and situation so that the rest of the family could learn
598	through that experience. Do you understand?
599	
600	***: Yes.
601	
602	C: The length of time that that soul would undergo that condition
603	or situation would be determined by how quickly the rest of the
604	members of the family were to learn their lesson. Of course, you
605	have the laws of nature to contend with. There is just so much
606	damage that can be done. After that, it cannot be reversed through
607	the known laws of nature. Do you understand?

608	
609	***: Yes.
610	
611	C: So there are a number of variables that one must take into
612	consideration with a situation like that. So, those souls that come
613	into the material manifestation as a benefit for mankind or for
614	those round and about them may suffer only for as long as it takes
615	those round and about to learn their lesson, and again, this
616	need not always be the case. Very well. Does this answer your
617	question?
618	
619	***: Yes, thank you very much.
620	
621	C: You are most welcome.
622	
623	***: Just as underpayment of a debt or payment less than the debt
624	would be unfairness, doesn't it seem that overpayment of the debt is
625	unfair too?
626	
627	C: There can be no such thing as overpayment. That is what we
628	said about some souls who are a little more zealous than
629	others. Do you see?
630	
631	***: Yes, but then you said except in the case where one changes
632	to become an example and they may suffer more than what they would
633	have to. Where does the excess merit go?
634	
635	C: That is not considered excess merit. In the case of those who
636	choose to suffer as an instructional example for others, that is
637	simply what they have chosen to do. They learn nothing from the
638	situation, if it is a true advanced soul who comes into that
639	situation or condition. They are merely enduring that
	, , , ,
640	situation or condition as a service to others. They have already
640 641	

- 643 \*\*\*: I guess I do, but it seems like a hard way to do something.
- 644
- 645 C: Well, this is the nature of godliness, to do what is necessary
- 646 for others in the concept of love and the expression of that love.
- 647 It is out of love that these souls come into the material
- 648 manifestation as a learning experience for others. Do you
- 649 understand?
- 650
- 651 \*\*\*: Yes, I think it is strictly voluntary. They choose to be of
- help because of their godly nature. Yes, I understand.
- 653

654 C: Yes. It is because they love each of those that they will come 655 in contact with or they love mankind as a whole, knowing that they 656 are a part of them, they are spiritually related to them. So they 657 come into the material manifestation not because they need the 658 experience but because the material manifestation needs a lesson to 659 learn. So, out of love for their brothers and sisters they return to 660 the material manifestation and will undergo whatever the situation 661 calls for. But those who must deal with such experiences, when they 662 truly put themselves forward to help that situation or when they 663 truly put themselves out to help those situations, those souls are 664 touched very deeply with spirituality and insight, and those souls 665 who must deal with those situations can make great strides 666 spiritually, if they truly apply themselves to those situations. 667 So, it truly is a plus then for those who are in that condition or 668 situation. Now, we are not talking about the soul who comes in as 669 a teaching tool, but we are talking about those souls that must 670 learn in that situation. Those who apply themselves make great 671 strides forward. Does that answer your question? 672 673 \*\*\*: Yes. 674 675 C: Very well. 676 677 \*\*\*: I was thinking about the suffering, some are here to help

678	others and they go through that to help others, and others suffer
679	for a variety of reasons. You said earlier that when someone's
680	life is taken that they are given the benefit of the doubt that
681	they would have done what they needed to do had they lived out the
682	course of their life. I was wondering how that would apply to even
683	older people who lose their life at the age of 50 or 60 who had not
684	been trying their best. Are they still given the benefit of the
685	doubt if the normal course of their life had taken them another
686	four or five years?
687	
688	C: If someone robbed them of their life, as a general rule, again,
689	as a general rule, they would be accredited with accomplishment.
690	Do you understand?
691	
692	***: Yes.
693	
694	C: Now, when one gets into that late in life, it can be, in
695	certain situations, kind of obvious that they really are not going to
696	do what they came in to do. Do you understand?
697	
698	***: Yes.
699	
700	C: So in a situation like that one must really consider the
701	overall activity of the life. If it has gradually leaned towards
702	fulfillment, then without a doubt accomplishment would be
703	accredited to the soul, but if there is an obvious pattern of
704	rejection of the Divine, then a question could arise as to whether or
705	not that soul would be accredited the accomplishment. It is a
706	situation where each case would have to be considered on its own
707	merits. Do you understand?
708	
709	***: Yes.
710	
711	C: As a general rule, you could safely say that the soul would be
712	accredited the accomplishment of that lifetime. That is only as a

- 713 general rule. Does that answer your question?
- 714
- 715 \*\*\*: Yes, it does. Thank you.
- 716
- 717 C: It really does not take too much to get the benefit of the
- 718 doubt. Just the tiniest of efforts weighs heavily in your favor.
- 719 That is why we have said that it is much harder to do what is wrong
- than to do what is right. Very well.

722 \*\*\*: We had a question similar to the one about the centaurs and 723 the half-man-half-animal but a little closer to our time in 724 history, did slave owners throughout history come back as slaves? 725 Or specifically, did they reincarnate as Negro Americans to 726 experience racism from the view of the victim? 727 728 C: Do you think that the Negro is the only race that has 729 experienced the injustices of man? 730 731 \*\*\*: No, certainly not, but that is used as just one example. 732 733 C: Just so you keep in mind that they are not the only race. You 734 can rest assured that that has happened, more often than not.

# Reincarnation was discussed on 83-05-21, the 114th Trance. The word "reincarnate" was first found on page 1846, line 88.

36	***: You stated in this 8th dissertation that there are those who
37	have chosen in their lifetime or in their material manifestation to
38	undergo conditions that may not be pleasant. The quote continues
39	later that many people in the world today suffer from either
40	disease or lack of food. My two questions on this are: What is
41	the difference between souls who live under such conditions as
42	victim souls and those who live under such conditions who are not
43	considered victim souls?
44	
45	C: Those who live under such conditions that are not considered
46	victim souls live under such conditions because it is part of their
47	karmic situation or debt. Those who enter into the material
48	manifestation under the classification of victim souls are those
49	souls who have, how shall we put it, surpassed the need of
50	reincarnation and enter the material manifestation as an
51	effort to alleviate the overall karmic debt or karmic situation.
52	Does that answer your question?
53	
54	***: Yes, I think so.
55	
56	C: Now, there are occasions when victim souls may come in on a
57	basis of assisting either a small group of individuals or even a
58	single individual, but this is an extremely rare situation. As a
59	general rule victim souls enter the material manifestation in
60	groups and more or less for the purpose of helping a larger
61	situation than that surrounding just an individual or a small group
62	of individuals.
63	

- 64 \*\*\*: Do those who choose such a life, not as victim souls, I guess
- 65 be because of their karmic situation, do they receive extra credit?

- 66 Does such an existence make it easier for them to reach the God-
- 67 Made Heavenly Realms?

- 69 C: That depends on the individual soul or individual entity.
- 70 There are some souls who advance greatly under adverse conditions,
- and there are other souls who do not.
- 72
- 73 \*\*\*: Are there ever any souls who are not victim souls who do not
- 74 have that karmic situation, who take on that type of material
- 75 manifestation for any other reason?
- 76
- C: There could be such situations. You must remember there are
  overall general rules, if we may use such a term, or general
  patterns, but since you are an individual, you have your own
  personality, and you have a free will choice always, you can weave
- 81 in and out of the general pattern of events according to your own
- 82 personal needs or desires, so there could even be such a condition
- 83 that would exist.
- 84

85 \*\*\*: This is one example or thing that I was thinking of. The 86 creation of channels for reincarnation are being limited in our 87 society and what we consider advanced societies and there are still 88 many beings who need to reincarnate. I was wondering if a soul who 89 needed to reincarnate but didn't need such a bad situation would 90 take that on just to get down here and get it over with instead of 91 waiting for the proper opportunity in a more advanced situation 92 like ours where the channels are being eliminated. 93 C: Again as a general rule this would not be the condition. There 94 is an inner awareness that prevents you from overtaxing yourself. 95 You must remember that the standard of judgment that lies within 96 each individual soul is that Christ Consciousness. Now, there are 97 some, shall we say, overzealous entities or souls that will attempt 98 to be much more severe with themselves than is necessary, but 99 eventually the just and righteous aspect of their being corrects 100 such overzealousness. Do you understand?

101	
102	***: Yes.
103	
104	C: Now there are times when a soul will enter into such an adverse
105	condition, not only for their own karmic correction but also as
106	part of their plan to help in correcting say a situation of a minor
107	status. Do you understand?
108	
109	***: No, I don't think so.
110	
111	C: No. Very well. Suppose according to your karmic debt it was
112	necessary to enter into the material manifestation under extreme
113	hardship, or let us put it this way, extreme hardship say in this
114	country of yours, and in your decision then it came to your
115	awareness that by entering into a similar condition in another land
116	where there was much famine you could assist the family that you
117	would enter into by your example, then it is quite possible you
118	would make entrance into that foreign land instead of here, thereby
119	accomplishing or having an avenue of two opportunities. In a situation
120	like that, one might consider entering into the foreign land as being
121	overly severe with self, but then again that would be the
122	consideration of someone else or another entity. Do you
123	understand?
124	
125	***: Yes.
126	
127	C: Are you sure?
128	
129	***: I thought I was sure.
130	
131	C: Very well.
132	
133	***: In speaking of the victim souls in what so many of us think
134	of suffering physically I believe you also stated that they
135	undertake emotional suffering. Now in what way would this help

136	those around them?
137	
138	C: Living in fear. Say a soul were to enter into a situation
139	where they lived in fear, the compassion that other souls or
140	entities should have for such a condition. Do you understand?
141	
142	***: Yes.
143	C: Through that compassion then that fear should be eliminated,
144	if the compassion is practiced.
145	
146	***: But fear of what, please?
147	
148	C: According to whatever the situation is. You give us an
149	example.
150	
151	***: Well, I suppose paranoia.
152	
153	C: Suppose you were to take a group of souls who were born into,
154	shall we say, a concentration camp situation. That would be your
155	example. Paranoia would not really suit the example.
156	
157	***: Would these souls ever end up in mental institutions through
158	the emotional stress?
159	
160	C: Certainly, it is quite possible. You must remember they come
161	into the material manifestation with all the potentials that the
162	material manifestation offers them. Do you understand?
163	
164	***: Yes, yes, I do.
165	
166	C: Very well.

# Reincarnation was discussed on 83-05-21, the 114th Trance. The word "reincarnation" was first found on page 1865, line 1024.

938	***: Concerning victim souls you stated, "during certain times of
939	the material manifestation large numbers of souls are released from
940	the material manifestation by one reason or another." What is the
941	reason? And "those souls usually will or, shall we say, a segment
942	of those souls who are predestined for the God-Made Heavenly Realms
943	will enter and move as a unit." What do you mean by move as a
944	unit? Would they be together?
945	
946	C: Moving as a unit, yes. That would mean that there would be a
947	number of souls who have undergone similar experiences and have
948	decided to work as a group or a family or a unit and will enter
949	into the material manifestation, not necessarily in the same area,
950	they may be scattered about the material plane, although they could
951	enter in the same general location. The term "unit" was meant unit
952	in a spiritual sense. They were of equal quality as far as soul
953	value. Do you understand?
954	
955	***: Yes.
956	
957	C: Now that does not necessarily mean that they would enter, shall
958	we say, all into this country at one time. It may mean that a
959	large segment or unit may enter into this country and many other
960	countries at the same time, yet they could enter all into one area,
961	if they chose. They are united and of like in a spiritual sense
962	but are not bound to the same activities in the material
963	manifestation. Does that answer your question?
964	
965	***: Yes, that does answer my question, thank you.
966	

967 C: Now, as far as being released or undergoing an activity where

968 they would be released from the material manifestation as a unit. 969 This could be given the example of, shall we say, a war when large 970 numbers of souls are released from the physical body due to the 971 war. Again, if a war were to last ten years, once you leave the 972 material manifestation there is no time; consequently, you would 973 look at those souls in that situation or in that war as leaving all 974 at the same time, yet in your observation it would be over a period 975 of ten years, shall we say. So those souls in a condition like 976 that leaving the material manifestation and becoming victim souls 977 would do so because of the injustice imposed upon them. Now, that 978 is only an example, that is not necessarily the general rule. Very 979 well. 980 981 \*\*\*: Thank you. 982 983 C: You are most welcome. 984 985 \*\*\*: Let me try to get this straight. You have so many souls that 986 are killed in a war situation or whatever the situation, and then 987 some of those, they are not victim souls at that point, but some of 988 those choose to return as a unit to help in a future time through 989 another life, that is when they become victim souls? 990 C: Yes, the manner in which they die does not necessarily indicate 991 or the reasons for which they die does not necessarily indicate 992 that they are victim souls, although this can have much effect on 993 the individual soul and his free choice in becoming what is 994 referred to as a victim soul. A soul achieves that title and that 995 honor when that soul determines it will re-enter the material 996 manifestation not because it must but because of its love for those 997 souls entrapped yet in the material manifestation. In most cases 998 they will enter into conditions that are most adverse. Do you 999 understand? 1000 \*\*\*: Yes. 1001

1003	C: The manner in which a soul leaves the material manifestation
1004	may impart in that soul a great deal of love and compassion that
1005	they would not have had were it not for that experience.
1006	
1007	***: So then the method of departure, whatever caused them to die
1008	could in fact cause them to grow more spiritually?
1009	
1010	C: It could, yes, also the reasons or purposes for dying, not
1011	necessarily just the way of the death. Do you see? When one
1012	stands up for what is just and right according to Divine
1013	Principles, if they undergo a death because of that principle that
1014	they hold true to, this brings a great deal of awareness to that
1015	soul. Do you see?
1016	
1017	***: Yes.
1018	
1019	C: You would be surprised how many little tricks, if we may use
1020	the term, can be pulled in order to gain permanent release from the
1021	material manifestation. Although they would not seem so trivial to
1022	you or to the material manifestation, but there are some, how shall
1023	we put it, sure-fire ways of getting out of the cycle of
1024	reincarnation. Now, we do not suggest giving such activities
1025	serious thought.
1026	
1027	***: But if the opportunity comes along, it wouldn't hurt to take
1028	it.
1029	
1030	C: Well, we certainly would not advise you to take it, but at the
1031	same time we would not advise you not to. We would suggest that
1032	you look at your responsibilities that you have and let that be a
1033	governing factor. You have an obligation to your situation, so you
1034	must weigh those obligations, also. Does that answer the question?
1035	
1036	***: Yes.
1027	

1038	***: Could these also be souls who have been taken in natural
1039	disasters such as earthquakes and things like that?
1040	C: Such disasters can offer a soul a great awareness at a
1041	spiritual level. Say for instance you have an earthquake and you
1042	as an entity, a physical entity, attempt to save some child in a
1043	building that is collapsing and you lose your life because of that
1044	activity, it is quite possible that you would have nothing more to
1045	worry about. You would have made it. You see, it is the reasons
1046	behind the activity. If you attempt to save someone's life because of
1047	your concern for that individual and you have no true regard for your
1048	own safety, the desire to reach out and help weighs very strongly
1049	on your side.
1050	
1051	***: Thank you.
1052	
1053	C: You are most welcome.
1054	
1055	***: A nice, quiet, peaceful death such as very quietly dying in
1056	one's sleep. Has that been earned or has that been chosen for a
1057	specific reason? And if it has been chosen for a specific reason
1058	can there be spiritual growth via that particular avenue?
1059	
1060	C: There is nothing wrong with a very peaceful and quiet death.
1061	One can consider that a reward for achievements if one chooses, and
1062	one's activities in the previous lifetime can give then that soul
1063	or that entity the opportunity in another lifetime to die
1064	peacefully. We are not advocating everybody running around and
1065	hunting for a terrible way of dying as a means of gaining the
1066	spiritual realms.
1067	
1068	***: Yes, I, of course, understand that. It would be such a nice
1069	way to go.
1070	
1071	C: In actuality, most individuals, most souls, leave the material
1072	manifestation quite peacefully. You know, the way your world is

4070	teda - 10 - e constante e coldere e constant (11 becebber (colder)
1073	today, if you can reach an older age and still be able to look
1074	around you and see something beautiful in an individual, that says
1075	quite a bit for that soul. With the way your world is today, you
1076	must work very hard to even think about being loving, so those of
1077	you who find it easy to love in your world, that speaks highly of
1078	you. Very well.
1079	
1080	***: (***) had a question. Concerning victim souls becoming
1081	involved in a war situation and your answer had been to that
1082	question, "to play silly war games would not be a part of the
1083	action of victim souls." (***)'s question is, Could some of these
1084	victim souls get stuck in fighting a war even though it may be
1085	against their nature?
1086	
1087	C: Yes, they could get stuck in fighting a war but they would not
1088	be proponents of that war. They would not be those who would, how
1089	shall we put it, determine a need for a war. They themselves
1090	could be considered victims of the war, whether they were on the
1091	winning side or the losing side, whether they lived or died.
1092	
1093	***: In a war situation could those who are killed or suffer
1094	torture that are not politically involved in the war, could those
1095	be victim souls?
1096	
1097	C: That could bring an awareness to them where they would choose
1098	to become victim souls, yes.
1099	
1100	***: But in the war situation itself, say they were peasants in a
1101	country, for example, and they were not fighting, they were simply
1102	there, and they may be killed and massacred and so forth, they
1103	themselves would not be victim souls?
1104	
1105	C: If they made entrance into the material manifestation knowing
1106	full well that they would be pawns in this war, then yes they could
1107	be considered victim souls. If their intent or purpose for making

1108	entrance into the material manifestation was to be utilized as a
1109	pawn yes then they would be considered victim souls. Does that
1110	answer your question?
1111	
1112	***: Yes, thank you.
1113	
1114	C: Now you must also keep in mind that not all those who are
1115	victims of a war are victim souls.
1116	
1117	***: In the situation I just described about peasants who are not
1118	politically involved, could their purpose be to create compassion
1119	in the souls of others?
1120	
1121	C: If they were the victim souls, yes, their purpose could quite
1122	possibly be to give the, shall we say, barbarians an opportunity to
1123	show compassion or concern. At the same time some of those
1124	peasants may justly deserve those activities because of a karmic
1125	situation. Do you understand?
1126	
1127	***: Yes.
1128	
1129	C: So that you realize that not all those who would undergo such a
1130	condition would be victim souls. Some would be there to justly
1131	reap their rewards. Do you understand?
1132	
1133	***: Yes, thank you.
1134	
1135	C: You are most welcome. You see, the victim souls offer those
1136	that they come in contact with an opportunity to demonstrate a
1137	godliness, that would probably be the easiest way to consider
1138	victim souls. This does not mean that in a war all those who
1139	apparently are massacred unjustly are victim souls. Many of those
1140	who undergo such terrible ends are simply reaping what they have
1141	sowed. Very well.
1142	

1143	***: It is still the duty of mankind to try to prevent that type
1144	of activity even though some people deserve it.
1145	
1146	C: What activity do you make reference to?
1147	
1148	***: All right, some souls might deserve to be taken out and shot
1149	in a village raid in some jungle war, but it is everybody else's
1150	duty to try to stop that situation from happening, to prevent the
1151	suffering?
1152	
1153	C: What right do you or anyone have in causing pain and suffering
1154	to another soul?
1155	
1156	***: No right.
1157	
1158	C: Does that answer your question?
1159	
1160	***: Yes.
1161	
1162	C: When mankind realizes that he has absolutely no right to cause
1163	another brother or sister pain or sorrow, when mankind realizes
1164	that you will also have a better world. Very well.
1165	
1166	***: (***) has another question in regards to victim souls. As a
1167	general rule, do victim souls come in as a group? And are they at
1168	times involved in laying the foundation for a future plan or
1169	activity?
1170	
1171	C: Yes, they can.
1172	
1173	***: Also, could they come in as individuals or a group to be a
1174	foundation for a past event that is necessary in the spiritual
1175	cycle?
1176	

1178	
1179	***: I don't think I can make it any clearer.
1180	
1181	C: Then go to the next question.
1182	
1183	***: (***) had this question. Concerning the situation of victim
1184	souls you stated, "It can be compared, now this is only a
1185	comparison, it can be compared to the attitude of the sacrificial
1186	lamb, the innocents and the slaughtering of the innocents." Are
1187	you referring to the slaughtering of the Holy Innocents?
1188	
1189	C: Again, what is the definition of "Holy Innocents"?
1190	***: In the story of the birth of Christ, all the male children
1191	under two years old that were slaughtered to prevent Christ from
1192	living that were slaughtered by King Herod. I think that is what
1193	she is referring to by the Holy Innocents?
1194	
1195	C: All right. With that definition restate your question.
1196	
1197	***: Regarding your statement "It can be compared, now this is
1198	only a comparison, it can be compared to the attitude of the
1199	sacrificial lamb, the innocents and the slaughtering of the
1200	innocents." Are you referring to the slaughtering of the Holy
1201	Innocents?

1203	C: That could be a comparison, yes

### **Reincarnation Revisited**

## Reincarnation was discussed on 83-06-20 the 115th Trance. The word "reincarnation" was first found on page 1879, line 215.

42 \*\*\*: My assumption is that I should lay a little bit of groundwork, 43 indicate what I am doing and on what I am trying to find out. I have 44 been on a committee of (\*\*\*) which has been studying a number of 45 the so-called psychic divulgences, and the purpose has been to 46 discover in these various communications the similarities in 47 responses on certain kinds of things that have to do with our 48 living of our everyday life, and I know the group that we are 49 meeting with tonight is very much interested in all those things, 50 also. Now, we had a list of about twenty books, most of them I 51 have read and I would like to ask some questions about those books. 52 I would also say that before I came into the area of study of psychic 53 and paranormal work that I was very much interested in the importance 54 of individual freedom and the problems that seemed to be associated 55 with loss of that freedom since our Declaration of Independence. I 56 feel very strongly that individual freedom is being taken away 57 through lack of understanding of its importance by the populace in 58 general and therefore many of our elections have gone in the 59 direction of persons who would take over the direction of our daily 60 lives to a greater extent through processes that would be similar 61 to or might be called socialism. So that is the kind of a 62 background of the kinds of things I am interested in, and I would 63 now like to ask questions about some of the books, unless there is 64 any response you would like to make to what I have just said. 65 66 C: The only thing that we would ask is that whatever opinions 67 we would express on this or that source of information, we would 68 suggest that we are expressing it to you personally and it is not 69 our intention to cast, how shall we put it or, shall we say, 70 discredit any sources of information. It should be your

71 understanding that all sources of information serve justly segments

72	of souls. Do you understand?
73	
74	***: I think I do.
75	
76	C: There would be some sources of information that would be of
77	less quality than others, but even in that they serve a segment of
78	souls. If we disapprove of this or that philosophy or source, we
79	would appreciate that that disapproval would be kept to a limited
80	number of individuals or to their awareness. Do you understand?
81	
82	***: Yes, it would be likely that I would not in any things that I
83	wrote would not be quoting a source here in any case, therefore
84	your responses would simply help me to make up my own mind as to
85	directions I might go.
86	
87	C: As long as you keep in mind that each source serves a group of
88	souls, and it is not for us to deprive any group of their food.
89	Very well.
90	
91	***: Well, since many of these books were of my selection,
92	actually they spoke to me and might not to many other persons, but
93	the group of books that I have had the greatest confidence in are
94	those written because of the work of (***) and (***) starting with
95	the (***), (***), (***), and so on, then going down into the (***)
96	which were never formally published as a book but which would seem
97	to me to be of a most profound meaning, and I would like to get a
98	general statement from you regarding the whole (***) work.
99	
100	C: From its level of origin it basically gives a good symbolic
101	view of what transpires. It would be geared more, shall we say,
102	for the intellectual understanding than to stimulate the actual
103	spiritual awareness of the individual reading it. In that
104	particular source it begins to paint a picture that shows too much
105	rigidity and formality that does not truly exist. Do you

106 understand?

107	
108	***: No.
109	
110	C: You have too much of a structured society or development. One
111	must remember that the development of the soul is not truly set by
112	any structure other than its own evolvement, but because it is one,
113	shall we say, item or one segment from an original source the basic
114	foundations of evolvement are naturally installed in there.
115	Consequently, there is a universal awareness of evolvement. Does
116	that make it any clearer?
117	
118	***: All right.
119	
120	C: In other words, basically, what we are saying is that the
121	evolvement of the soul is done through a process of inner
122	evolvement outward and in this process it could be viewed as a
123	structured society. Does that make it any clearer?
124	
125	***: The structured society that gets by me a little bit.
126	
127	C: In other words, take an individual soul. Once it has evolved
128	beyond the awareness of the physical plane, now we are talking of
129	the soul's position in a spiritual state. Do you understand?
130	
131	***: Yes.
132	
133	C: Once it has evaluated its activities in the physical plane, it
134	has a tendency then to project an illusion outward to sensitives
135	that may be observed as a structured society. Do you understand
136	now? When in fact it is only the individual soul's way of
137	projecting an evolving process within the soul itself. Now, is it
138	any clearer?
139	
140	***: Are you saying that the view of society that I project that is
141	the one that I perceive then would be in the form of a structured

142	society by taking what you call a more formal view that the (***)'s
143	may have indicated.
144	C: Let us put it this way. Possibly, you are looking at the
145	descriptions too literally. Reconsidering your understanding from
146	the point of view that it should be the inner structure of each
147	individual's own consciousness and the total personality of the
148	individual soul. Does that make any more sense now to you?
149	
150	***: I realize that it is the inner development which is necessary
151	and taking just as an example my acceptance of these books, at the
152	time that I came upon them I did not believe in a life beyond death,
153	and so forth, and it took the intellectual understanding of that for
154	me to get into the deeper things having to do with inner development,
155	and so they have seemed to me then to be quite important and perhaps
156	they are not quite so much so to a large measure of the population.
157	
158	C: They act as a stimulus for you, but consider again what we said
159	before. Your observation of what you read, the intellectual
160	digestion of that information. Do you understand?
161	
162	***: Yes.
163	
164	C: Is too rigid. Now, observe that information, not in the manner
165	of a true structured society, but observe it from this point of
166	view that what is described there is the inner evolvement of the
167	soul itself projected through the sensitive as a society. Now do
168	you understand?
169	
170	***: I don't and if there is anybody else here
171	
172	C: They won't; they won't; they won't. Now, listen again. It is
173	simple, really. What is projected as a social structure. Do you
174	understand so far?
175	
176	***: What is projected as a social structure by them or by me?

177	
178	C: By them, by the source, by the entities working through the
179	source. What is projected as a social structure is, in fact, not a
180	social structure at all but is the inner structure of an individual
181	soul. Now, do you understand?
182	
183	***: I think I do.
184	
185	C: Because of the sensitive's processing the information there are
186	times when it is presented in a physical universal concept painted
187	against the backdrop of a society. Now do you understand?
188	
189	***: I believe.
190	
191	C: Only for illumination or understanding but one must see beyond
192	that. What is talked about basically or at a deeper level in the
193	(***) material is the evolvement, the inner structure, the inner
194	society of an individual soul. At a soul level you are a universe
195	unto yourself. You are a society unto yourself, and you are made
196	up of a number of levels of awareness, and at times the
197	transference of this information to a sensitive and then into some
198	medium or material of some sort, it can be transposed, let us say,
199	in too basic of a concept. Do you follow?
200	
201	***: You say too basic?
202	
203	C: Yes. In other words, it leaves you with the idea this is
204	the way it is and does not allow the mind to see beyond just the
205	words. Do you see?
206	
207	***: Well, I still have some confusion there, I wouldn't want to say
208	I understand that wholeheartedly, but I think I do follow your general
209	direction on it.
210	C: The term "too basic" is meant to convey too primitive, too
211	child-like, too much word for word, too literal. Do you

212 underst	tand?
-------------	-------

214 \*\*\*: That may fit in to what we find in a number of these and

215 I say particularly in the discussions of reincarnation because

216 in many of these references they say it is different than the

217 generally accepted view.

218

219 C: It is so different that the human mind would find it, well, 220 almost impossible to conceive. You may be able to retain some 221 vague idea, but the process of dying and going to a Spirit Level 222 and then returning again, one life after another, is far easier to 223 deal with than the true expression. First of all, since you are 224 tied in to the illusion of time it makes it easier to understand 225 the activity of the individual soul or yourself if it is related or 226 conveyed to the conscious mind in a 1-2-3-4-5 experience. Do you 227 understand? 228 229 \*\*\*: Yes.

230

C: Actually, it is a 1-2-3-4-5 experience going on simultaneously,

232 only because time does not exist in a spirit state. Your true

233 state of existence is a spirit state. Anything other than that is

a pure illusion of the soul. In other words, it is "mind games" of

235 the soul. Does that give you a hint?

236

237 \*\*\*: Yes.

238

239 C: Now, one must be careful not to read into this now existence

the attitude of multiple personalities within the individual soul.

241 The multiple personalities in an individual soul is not consistent

242 with true awareness of spirituality. There is only one

243 personality to the soul, but the soul's abilities far surpass what

the conscious mind can understand. It is the individual soul and

its individual personality that is able to move from experience to

246 experience as it needs or as it sees fit, moving each life along

247	according to the overall development that is going on at the same
248	time. Does that make much sense?
249	
250	***: Yes, it does.
251	
252	C: Very well.
253	
254	***: And going on with that. It took me a long time to get to
255	that point, but I still resist it to this extent, that is, resist
256	the idea of staying with the generally accepted view because it
257	seems to me that so many persons, particularly in organizations
258	like the (***) and so forth, they get so hung up on reincarnation
259	itself that we get a whole host of ideas which it would be a
260	good thing if we would disengage from them, and pay a little
261	less attention to interpreting everything in the reincarnational
262	aspect.
263	
264	C: Well, don't you really think that when you become that involved in
265	the reincarnation concept or the past life concept, it is more or less
266	an ego trip? Actually, if one has an interest in other experiences
267	it should only be to the degree that you are interested in
268	understanding what was achieved spiritually and what was, shall we
269	say, charged against the soul spiritually. Other than that
270	knowledge of previous experiences basically can be considered
271	egotism. If you can understand or you can come to the awareness of
272	qualities achieved or defects allowed to form within the soul, then
273	this possibly could be helpful in certain occasions, but beyond
274	that it is purely egotism. That is why we do not ponder on
275	reincarnation or past life experiences.
276	
277	***: One of the reports that we were going to write up was on
278	reincarnation and I was going to write that one, and so then I would
279	ask the question, is it worthwhile to suggest some of these things
280	because there will be, it seems to me, some people who will then
281	begin to understand that it is an other-dimensional thing which

- 282 cannot be comprehended in the physical plane?
- 283 284 C: Possibly approaching such an article first from the traditional 285 concept and then expanding it into the thought that possibly the 286 concept is perceived in that manner only because of the limitation 287 of the human mind, but its true state of existence is an all now 288 and everpresent existence. Consequently, all these lifetimes are 289 going on not necessarily simultaneously but as the soul needs the 290 experience in that particular activity or that particular life 291 experience. How does that sound to you? 292 \*\*\*: Pretty good. 293 294 C: You do not want to feed a child solid food, when it still needs 295 pablum. Do you understand? 296 297 \*\*\*: Yes. 298 299 C: But it never hurts to spice it up a little bit. With something 300 like this to approach it from the concept that is easily understood 301 and then opening the door a little bit so that they may look 302 through it might be much more beneficial than pushing the individual 303 right through the door. It is extremely hard to look at the 304 everpresent now and understand it, but it really is far simpler 305 than man's observations of his existence, which is entirely, well, 306 let us put it this way, a very naive concept, yet that is all he is 307 truly capable of understanding in terms of being useful to him at 308 the level of the soul development or his activities in the material 309 plane benefiting the soul development. Do you understand? 310 \*\*\*: Yes. 311 312
- 313 C: Very well.

## Reincarnation was discussed on 86-08-22, the 141st Trance. The word "regression" was first found on page 2307 line 701.

\*\*\*: I have another question on hypnosis. When you are talking
about how it can be dangerous, I would just like to hear your
comment on regression into past lives under hypnosis. Is that
something you are referring to as a danger area? Or is it in any
way beneficial?

704

705 C: It can be dangerous; it can be extremely dangerous, and it can 706 be also beneficial. We do not advocate past lives for this reason: 707 It has a tendency to add to the ego, which is, of course, adding a 708 greater stumbling block. Now, that is the, how shall we put it, 709 unacceptable part of past lives. The positive aspects can help 710 individuals deal with situations. Where you divide the line is 711 when you receive a past life reading, if you receive past life 712 readings that pat you on the back and tell you how wonderful you 713 were and how you were the Queen of Sheba or Cleopatra or some 714 gracious queen, there are more Cleopatras and queens and what have 715 you running around, at least they think they are, than you have the 716 ability to count. Now, there was only one Cleopatra and one of 717 this and one of that, so this is the problem that exists. If a 718 past life tells you of the great things you have done, then it 719 is useless. It simply fans your ego. But when a past life reading 720 tells you the mistakes that you have done, then it is a very 721 constructive and beneficial past life reading, because those are 722 the items, those are the stepping stones or stumbling blocks that 723 you, in most cases, if it is a good past life reader will be able 724 to deal with in this present life or that you may have to deal with 725 in this present life. At times, for some individuals, knowing this 726 helps them to accept the situation they are in and deal with it 727 more effectively. Does that answer the question?

728

729 \*\*\*: Yes, it does. I had a question ...

730

731 C: May we make one more remark. As a general rule, we could not 732 encourage individuals to seek out past life readings. At times, we 733 ourselves dealt with such things in the very beginning of this, but 734 we also found no need to find favor or acceptance from those 735 individuals that requested such information so we were quite blunt 736 about their past lives. We gave them no details, but we told them 737 what burdens they had created for themselves in this lifetime. 738 Consequently, very few appreciated our honesty, but those who did 739 are far better for it now, because they have taken that information 740 and used it constructively for their own spiritual growth. So, if 741 you receive a past life reading telling you something that you must 742 correct, then use your common sense and see if you find that 743 element in you. Even though it may be hidden or only a touch of 744 it, use it constructively and try to overcome that weakness or that 745 defect or that problem. Then it is beneficial. But very few, 746 few people can see that deeply into the soul. There are a few who 747 can, but be honest with yourselves if you seek such things and ask 748 yourself what your true purpose of looking into your past is.

408	***: My formal question that is typed out here is: Why do
409	negative thoughts come into your mind in the first place?
410	
411	C: Probably because you do not have enough Well, we really
412	should not get this on a personal level, should we, (***)?
413	
414	***: I am not commenting one way or another.
415	
416	C: After such serious things, a little jest is good, and since
417	(***) can take it, isn't that right, (***)?
418	
419	***: Doggone right.
420	
421	C: Why do negative thoughts come into an individual's mind?
422	Again, it is something that there really is not an answer for. It
423	is an accumulation of what you are, what you have done. It is
424	impossible to eliminate every negative thought from your conscious
425	mind, but one should attempt to do is once the negative thought
426	enters, replace it with a more positive or constructive thought.
427	You cannot constantly be active twenty-four hours a day; you cannot
428	constantly have your thoughts elevated to the heavens; and it is
429	not expected. There are some natural thoughts that will come and
430	go in your mind, but it is the way you deal with such things will
431	determine what responsibility you have for that condition or that
432	situation. Do you understand?
433	
434	***: Yes. You mean a lot of the stuff that we drag with us into
435	the plan that we are unfolding when we come down or are
436	reincarnated, even though we might lay out, well I would hope we have
437	all laid out positive plans for growth

438 C: Well, not all.

439 440 \*\*\*: Well, I mean all of us people here. At least in western Stark 441 County. Even those who do have good plans or start out with good 442 plans, they still drag some of that dirty laundry with them that 443 they created in a previous lifetime that sort of bugs them as they 444 are growing up? 445 446 C: We are not so sure the term "dragging it with you" is as 447 accurate as it could be. It is definitely a part of you. It is a 448 part of the Subconscious area. Do you understand? 449 450 \*\*\*: Yes. 451 452 C: And the Subconscious is not something that comes and goes or 453 that you leave behind like your physical body. The Subconscious 454 Mind is simply another facet of the soul's awareness or the spirit 455 that is you, the unique personality that is you, and it is this 456 area that holds all the debts that you have encountered. Do you 457 understand? 458 459 \*\*\*: Yes. 460 461 C: And you as a spirit entity, you as the unique creation, 462 pick and choose according to the condition that you are in as 463 to what you are going to deal with. - this is wrong I must continue to do this so I can give my dear
- 496 friend here a longer time to evolve." We are aware of such
- 497 attitudes. Again, again, you fool only yourself. You fool only
- 498 yourself.

500 \*\*\*: Are these prepackaged plans that we make, the whole

- 501 strategies we set up before we come back down here, how often do we
- 502 jump ship and change plans?
- 503
- 504 C: There are some individuals, to use your terminology, have quite
- a track record of jumping ship, and, unfortunately, they may come
- to a point where they wish they had not. If you can keep this idea
- 507 in mind: Each time you avoid a learning lesson, the next time that

- 508 lesson comes around it becomes that much more serious, a much more
- 509 serious situation you have to deal with.

809	***: Back to what you said about if you hurt somebody who is very
810	good and they leave before you can make restitution, I am asking
811	this hopefully, is that referring to a long-term relationship with
812	that person where you use them or abuse them? Or are we stuck with
813	reincarnation for someone we may have run into for a brief time?
814	
815	C: The question was asked under the condition of a married
816	situation.
817	
818	***: All right. I am sure I am not the only one who can think of
819	somebody they have harmed who is no longer around. I would hate to
820	think I was already committed to reincarnation because of that.
821	
822	C: It depends on exactly what all was involved. If it is a
823	situation where you physically harmed a person, it may be that
824	restitution would have to be paid directly to that person or it may
825	be restitution is paid through some other means. But when you talk
826	about commitment, spiritual contracts, that is something a little
827	bit different than slugging a buddy in the nose under a heated
828	argument laced with bottles of beer and booze. Do you see?
829	
830	***: Yes.
831	

832 C: There is really no comparison. Very well, another question.

# *Reincarnation was discussed on 87-10-31, the 150<sup>th</sup> Trance. The word "reincarnation" was first found on page 2504, line 642.*

630 \*\*\*: This might take a little bend in the road here. I think we 631 all understand the idea of cell division. Now, when we get down to 632 multiple births, I understand for each baby be it twins, triplets, 633 or more, each one would be a separate soul, right? 634 635 C: As a general rule, yes. 636 637 \*\*\*: Okay, now. My question is: A few Trances back we 638 covered miscarriages, if the soul decided that it wasn't the right 639 time, the right parents, or what have you. Now, in the case of twins 640 and the time of delivery comes and one baby would die and one would 641 live, would there be a chance of these two souls maybe, now I am 642 bringing in reincarnation. 20 \*\*\*: All right. Do you have an opening statement to make? 21 22 C: Life that one experiences in the material form or the material 23 manifestation or in what you call living in the earth plane, is a 24 constant experience in decisions, a constant experience in 25 crossroads. How you handle each crossroad determines the final 26 outcome as to whether your life has been productive or detrimental. 27 As we have said in the past, the soul moves in only two 28 directions, in reverse or in growth. Because life is so complex 29 today, because one lives in a world where everything is instant, 30 life has become a matter of decisions, a matter of experiences; they 31 are guick-fired, rapid succession. Because of the way the world is, 32 life has become a matter of compromises. Those values that are 33 necessary for growth seem to never be fulfilled or experienced 34 completely. In years gone 54 by or in man's past history, when things were far more exact and 55 demanding, you knew exactly where you stood. Today, man cannot be 56 sure. Today, man must rely on his faith and his beliefs, but man 57 must be sure of his beliefs. He cannot claim to believe one thing 58 at one time, and something else at another time as it suits his 59 whims. He must take a firm stand on his beliefs and then act 60 accordingly. Live as well as he can within those beliefs. He must 61 do the best he can. This makes his future or his path not nearly as 62 certain as it used to be. In the times gone by man knew for sure 63 where he stood, by knowing exactly what he had done, whether he had 64 lived within the law or whether he had stepped outside of the law. 65 Today, in this time, in this portion of the spiritual cycle, it is 66 not so clear. What has man done but change one exact and demanding 67 period for a period not nearly as clear or as certain? A period 68 where man must look within himself and decide whether his actions 69 were based on truth and sincerity or whether they were based on the 70 ego. 71 Man often confuses the destructive ego for the productive and 72 necessary self-esteem. If man does not have self-esteem, then he 73 has ego. If a man has ego, he has no self-esteem. Self-esteem is 74 the godly side of ego. Self-esteem is what allows you to realize 75 the importance of you and the godliness of you. When you respect 76 yourself, when you love yourself, then you will conduct yourself in 77 a proper manner. You will have the right attitude and intentions 78 toward life. 79 Although in the overall examination of how things are, one 80 could truthfully say that those experiencing life in the physical 81 form now do in fact have an easier period of growth than those of 82 times gone by. The disadvantage is that the picture is not nearly 83 as clear, that one must hang onto that elusive phantom that you call

84 faith. In the past, man had absolutes. Which is best? Which is

the easiest? If all that is necessary to succeed to your maximum
spiritual growth in this lifetime is faith and self-esteem, then the
answer would be the road is much easier in this time period than
ever before.

One thing you must keep in mind and that is this: Your

90 responsibility for your actions extends only to the point of 91 understanding when they are not within Divine Law, but you must 92 fully understand that they are not. This allows an opening that few 93 seem to realize. As we have said in the past, we give you a blanket 94 yes or no to certain questions, but that is the governing factor. 95 From that point on there are circumstances that may vary that 96 absolute yes or that absolute no. Each has their own particular 97 balance in each situation, depending on the degree of understanding, 98 not the intellectual understanding, but the wisdom, the thing that 99 comes from the heart, the conscience, that little voice that 100 whispers with inside each of you and says, "This is not right," or 101 "This is right." Those who still have consciences are far ahead of 102 those who have hardened their hearts to that little voice. Those who 103 still have consciences will more than likely succeed in this 104 lifetime. If you can keep in your mind that you are made in the 105 image and likeness of this Divine Creator and that you definitely 106 have a purpose, if you can keep in mind to respect yourself, then 107 your chances of success, completing the circle of reincarnation can 108 be almost guaranteed. 109 Some may say, "Have the Divine truths been softened or 110 tempered?" No, no, but the world has become hardened and cold so 111 that there is a lack of understanding, an inability to see, and 112 since one is judged on their responsibility, their ability to 113 understand based on the circumstances that they find themselves in, 114 then the standards, you might say, are not as strict. The standards 115 still exist, but the compliance with those standards, out of 116 necessity, have been broadened. 117 If you doubt that you are a creator, because of the fact that

- 118 you have been made in the likeness and image of that Creator, look
- 119 at the opportunity for instant comparison in this: that you are

- 120 capable of producing life. It is your one touch with the Divine
- 121 ability to create, to create a new life and to create a new world.
- 122 Very well.
