AN INTRODUCTION TO THE COUNCIL by William Allen LePar

The Council has often referred to themselves as "spiritual beings." We must remember that this is a very elusive term and means something far greater than what we normally have been taught to understand as "spiritual beings."

In our finite minds we look upon spiritual beings as living beings confined in similar manners as we in the physical, and this is not the case with some levels beyond the physical. But in this expanded description from The Council, we begin to realize that there are levels that we can reach as spiritual beings that far surpass our present concepts.

Respectfully, I submit The Council's own personal description of themselves.

THE COUNCIL SPEAKS OF THEMSELVES

After a soul or an entity has accomplished a certain level or degree of perfection, through whatever system that is the ruling belief system of that time, then the individual or the soul or the entity is elevated to a level wherein it is not necessary for reincarnation. Once entering the spiritual realms without the need to reincarnate, a growth period is undergone. Many steps of awareness or many levels of awareness are accomplished, many degrees of elevation, many degrees of perfection until finally the soul, the entity has evolved into a state where there are no levels, no degrees, but begins to expand in love and awareness to the point where there is a total mergence or merging with other beings; where all ideas of limitations, all awarenesses of false limitations, have been done away with; where the person or the soul or the entity begins to realize its true unlimitedness and in that begins to expand greater and greater and greater, interweaving more delicately and more closely with all others and all other things, and in so doing grows closer to the Divine Himself. Once a soul or entity has reached this level, then they are in union with others, total union, yet completely individual, and yet completely united. This soul, this entity has its own personality, yet delicately flows in and out and with other souls but yet maintains its own personality, its own being. The soul, the entity becomes more god-like in that it becomes part of all things, vet maintains its own personality, its own being. Once a soul has reached this level then there is no name, there is no body as you would recognize or understand, but a more complete and unlimited Child of God, one who is so developed that no name could ever describe him. That is the existence we live in, and if you wish to use confining and restricting terminologies as levels, then we souls have to say that is the level we exist in. In all of mankind's history this level has never before spoken in the physical plane.

Even though we refer to ourselves as "spiritual beings," we use such statements only to give all who come to us some idea to relate to or some concept that they can relate to.

THE TRANCE PHENOMENON

We believe The Trances of William Allen LePar are the rarest paranormal experiences known to modern man. The only example of a similar phenomenon ended with the death of Edgar Cayce in 1945. The Council's unparalleled revelations, through Mr. LePar's trances, are made available to the public through the SOL Association for Research. His time and efforts are without compensation, and SOL is a non-profit, tax-exempt concern dependent on the commitment of volunteers.

The following is a brief explanation of a Trance, so those without the opportunity to participate have a better understanding of the phenomenon. On the day of a Trance, Mr. LePar remains in a peaceful environment. He consumes little food and The Council recommends his diet include red shellfish. He engages in considerable prayer and meditation throughout the day.

Those participating in a Trance, to question The Council, gather about a half hour before the session for socializing. Nancy LePar, his wife, is always the last to leave her husband before a Trance begins. She sits with him in a separate room as he quiets himself with prayer and meditation. When she enters the room in which the trance is to be conducted, all talking and noise cease. Soon he enters, silent and already in an altered state. With everyone seated and quiet, he enters, removes his slippers and positions himself on the floor.

He wears, as instructed by The Council, loose clothing of all natural fabric. Also, Mr. LePar wears no metal other than a wedding ring and cross. As he rests his head and bare feet on pillows, he maneuvers his body into alignment with magnetic north. Those participating, following instructions from The Council, are to place themselves in a quiet, prayerful state as until this remarkable source begins to speak. There are two distinct time periods in the linking of LePar's spiritual vibrations with those of The Council. The first period concludes with LePar's extremely deep and rapid breathing, a form of hyperventilation. His hands, folded across the abdomen, quiver; his left leg stiffens and his left foot extends. Then, suddenly, silence. It seems almost as if he has stopped breathing. Finally, The Council begins to speak -- slowly at first, repeating the name of the Trance moderator, until the link with the physical world is ready. It usually takes about thirty minutes from the time Mr. LePar lies down until The Council speaks. But on some occasions, for a variety of reasons, it can be as long as 45 minutes.

Once The Council begins to communicate, a Trance usually lasts between ninety minutes and two hours. The Council is offered the opportunity to give the gathering an opening statement, which has always become a segment of information useful for universal spiritual growth. Then, the trances follow a simple question-and-answer format, beginning with written questions and continuing with follow-up questions raised by The Council's comments. At some sessions, there are so many follow-up questions that only the first question asked will be from the list of written questions.

Afterwards, when Mr. LePar awakens, he remembers nothing. His memory is blank from the time his wife leaves him before each session until he awakens at the conclusion of the Trance. He is always physically drained, cold and disoriented. He is helped to a seat, wrapped in an afghan for warmth, and given a slice of bread and a glass of orange juice to help him recover.

We hope you profit from the information in these Trance Library Files. If reading a particular file gives rise to a question, we encourage you to contact us for more information. Thank you.

FOREWORD

The Council has told us on many occasions that truth has always been available to mankind from the very beginning. As you read this Trance Library File, you may note similarities to information from other sources. You will also encounter new information. You may be surprised by some of the information revealed by The Council, to the point where it strains your credulity. The Council realizes this, and so they often begin a Research Group Trance with an opening statement such as this:

Again, a reminder as we have said before, we ask that you think about what we have said, the answers to your questions. What is most important is that you do think, that you exercise your God-given mind. Use what you can use and store away that which is not serviceable at this time, for if you wish to see a dawn tomorrow with its clear blue skies, you must make ready for it now. If you cannot believe that tomorrow will be a better day than today, then it will not be so for you. If you do not carry the light of tomorrow, then where will it come from? If your tomorrow is not planned for today, then how can it exist? Forearmed with the knowledge of the path you are presently traveling, you are then in a position to create a better path for your travels tomorrow. The outlook for the children of the Divine is definitely a bright and sunny day. Only you can make the decision as to what your tomorrow will be. We have one distinct advantage over each of you, and that is we have gone through the process of life that you are presently experiencing and in those activities we have learned that one must never narrow their vision down to what they prefer to see, but it is great wisdom when one is willing to look at the total picture, even those segments that one wishes were not there.

Always keep this concept in mind: Use what information you can, and that which you cannot agree with, put it aside for now. Do not discard it, for you may find it very useful in the future.

208	***: Bill has a question regarding (***) who attends the Bible Study
209	Class regularly. (***) became distressed at the last class at the
210	comment that all abortions are equivalent to murder even in such cases
211	where it is known the baby is deformed and would have difficulty
212	leading a normal life. The examples (***) used were the
213	Thalidomide babies or when the mother had German measles. He wants
214	to know is there anything that he could tell him, tell (***), that
215	might alleviate some of his apparent anxiety and he has asked us to
216	state he really likes (***) and he is concerned and (***) has not
217	asked him for information, he is doing this on his own.
218	
219	C: Sometimes we wish he were not quite so clever in his wording.
220	Questions submitted in this manner put us somewhat on a spot. We
221	do not want to set examples for, or set, shall we say, means by
222	which such things can happen too often. If we were to address a
223	statement like this. Now mind the way we are saying this for
224	anything that may come up in the future. Is this understood?
225	
226	***: Yes.
227	
228	C: If we were to address a question and a situation as this, we
229	would address it as such. It is understandable for an individual
230	to be concerned about such situations where an unborn child is
231	known to be deformed in one way or another, but nevertheless,
232	because man does know that this condition may exist, he does not
233	have the right to extinguish that life. First, he does not know if
234	there is a soul there yet or not. There could very well be a soul
235	from the moment of conception to the actual birth. So in this
236	situation since man is not God, he is limited, he must act in a
237	limited way. No man has the right to take another life, and this

238	includes those that, unfortunately, will not be born whole or
239	complete. You see, this is the destructive thing of karma, you
240	see, that there are general karmic waves or karmic situations or
241	conditions that men fall into and are entrapped into because of
242	their contributing negativity in their present lifetime or in their
243	past lifetimes, you see; and even though a situation like this may
244	not be acceptable to a man, it must be endured because one does not
245	know what their God may have in store for that particular unborn
246	entity or that particular unborn baby. True, it may be deformed
247	physically or mentally, but it also may have the opportunity to
248	have that deformity corrected, you see. But man does not have the
249	wisdom of God, nor the knowledge of God, so he cannot foresee this;
250	and so he must let life live once it has been started. Once a man
251	and woman unite and they use their bodies as instruments of God's
252	in creating a living being, there is where their godliness ends.
253	There they have a charge that they must accept and maintain. No
254	man nor does any woman have a right to cease life within the body.
255	If life has been placed there, it is there for a reason, and since
256	you do not have the mind or the knowledge of God, you cannot see
257	what that reason is. You see the unending struggle that the old
258	way has for man. It is an unending struggle and such things as the
259	ceasing of a life only entraps an entity or an individual in karma
260	that is almost impossible to rid oneself of. We said almost.
261	If an individual whether it be a man or a woman should come to a
262	point in his life or her life where she has made such a decision or he
263	has made such a decision, there is not much that can be done, and the
264	advice that we give for such people is an advice that is drenched with
265	hope and filled with hope, if they are wise enough to listen to the
266	advice. And that advice is this: That if that person were to turn to a
267	true Christian attitude and a true Christian belief, then he would
268	place or she would place all those things in the Hands of the Divine
269	God, and let that Divinity, that Source of Life, that Source of Love,
270	take care of the situation as He sees fit. You see, there are many
271	things that man knows of God that he does not always realize, and that
272	is if God is Love, then Love constitutes more than just the word "love."

273	But God constitutes all the qualities that make for a perfect being,
274	and one of the qualities that constitutes making a perfect being is the
275	quality of forgiveness. This, most assuredly, is a quality your Divine
276	Father has as is the quality of the Divine Lord Jesus Christ, and if
277	an entity male or female is responsible for such a situation, if they
278	were to believe, have faith, that this Divine Father does love them
279	in total, then all that is necessary will be given to that
280	individual to correct what mistakes that individual has made in
281	this particular lifetime, so that there will be no need to undergo
282	what might have been indebted, what that entity may have indebted
283	himself to in another lifetime. Now this does not give one license to
284	commit abortion or murder time and time again. Once is all that
285	can be permitted.
286	In the case of (***), the gentleman we are addressing, if we
287	were addressing him, is that his attitude should be this: that if
288	an individual has done such a thing in whatever circumstances may
289	have been, that if that individual were simply to admit their
290	inability to foresee their weakness and their lack of understanding,
291	then that particular individual would be raised up from the
292	situation providing that individual realized and accepted the Love
293	that the Father has; but from that point on then that individual
294	could not repeat the same action nor could he maintain an attitude
295	that would permit such actions to be permitted. Now we feel that
296	someone who has found themselves trapped in such a situation can
297	very easily rid themselves of unnecessary karma, if they were to
298	follow the advice we have just given. We feel that this answer
299	would answer the question, if we were to have addressed the
300	question.

182	***: You said earlier that it is entirely possible that the soul or
183	spirit may be with the entity from the time of conception on. Why
184	would a spirit not be with it from the time of conception? Or why
185	would it come into the physical organism at a later date than
186	conception?
187	
188	C: There are a number of reasons why. One reason is or could be
189	depending on the situation, the entity that is, shall we say,
190	overlooking the situation may not be sure that the lessons necessary
191	for its growth will be there in that situation. The mother and
192	father may not have, shall we say, set firm conditions that that baby
193	will eventually grow into or develop under, so you see there is the
194	factor of free will there that must be considered in all three
195	individuals, the father, the mother, and the prospective child. In
196	many cases and possibly we should add here in most cases, the
197	conditions are set; the parents on a spiritual level have already
198	firmed or committed themselves to those conditions necessary for that
199	particular entity's growth. In that case then the soul or spirit
200	would immediately enter on the moment of conception. Now, another
201	factor you can take into consideration as a possibility in that is
202	this: that a soul may occupy that embryo or that fetus for some time
203	and then may decide for one reason or another to, shall we say,
204	switch horses in mid-stream. In that case then, there would be the
205	opening for another entity to take that position over.
206	
207	***: In the case of a miscarriage what happens?
208	
209	C: There again, you can branch out into many areas. It may be that
210	the spirit or the soul that was to occupy that position decided that
211	it would not receive the opportunities necessary so would leave. No

212 other soul or spirit choosing to occupy that situation, then, of 213 course, you would have a miscarriage. That is one possible situation. 214 Another possible situation would be in that a soul occupies that 215 fetus for a time and because of the necessary, shall we say, lesson 216 for the parents involved in a miscarriage, then that soul would leave 217 so that the miscarriage would take place, thus the parents growing 218 through the experience, and we might add growing in one direction or 219 the other. 220 221 ***: In the case of abortion, does the soul that had occupied the 222 fetus, are they aware that that act will be committed? 223 224 C: Again, you must remember that there is that element of free will, 225 right until the moment an act is committed. So although that option may 226 be in the horizon that is not necessarily a predestined experience 227 or happening; so although there may be a soul or spirit present and 228 although the opportunity may be on the horizon, it does not necessarily 229 mean that it will happen until the moment it does happen. In some 230 cases the awareness is there, but yet the occupation of the body or 231 fetus is still taken, and of course, in that situation then you know 232 what you have. That is why abortion is an absolute no; absolute no. 233 If man could determine whether there would be a soul present or not, 234 then possibly, and again, we say, POSSIBLY, there would be an 235 acceptance of abortion, but even at that it is not the natural thing. 236 237 ***: Does the soul or spirit sometimes enter the body after birth? 238 C: There are some who would say, yes, that a soul can hover over a 239 physical tool for quite some time. In one respect this is true, but 240 in another respect it is not true. There is such a thing as complete 241 control of the physical tool or body and an incomplete control. Now 242 there are rare, and we repeat again, RARE occasions when a soul does 243 not have complete control of the small body. In this case then one 244 could say that the soul does not fully enter the physical tool or the 245 physical body for some time after birth.

248 alive, the soul or the spirit. 249 250 C: It does; it gives it the life; but there is a chemical action 251 involved in the process of the physical body. You see, it is all 252 very natural. Do you understand? This element combined with that 253 element creates a chemical reaction and that chemical reaction can 254 trigger an electrical impulse; now that electrical impulse can also 255 then be responsible for causing two chemicals, shall we say, or two 256 elements to unite that would not normally unite and create another 257 electrical impulse; so there is a degree of life in a physical body 258 without a soul. Now it would be wise not to pursue that particular 259 line of information since it becomes an extremely complicated 260 situation in that it opens the avenue for such things as possession 261 and what have you.

612	***: What happens to the soul of an aborted baby and what are the
613	effects to the woman's soul who aborts this baby?

615	C: The soul of the aborted child is returned to whatever realm it
316	came from. Now, a question such as this would be better asked
617	under or, shall we say, in a situation where moral issues are being
618	questioned but because it is, shall we say, a topic of the day, we
619	will go into this particular question.
620	No one, and we mean no one, no psychic, no individual, can
621	positively tell when the fetus is being possessed by a soul. From
622	this point then abortion is not acceptable. There is no absolute
623	way to tell whether the soul is present or permanently present in
624	the fetus, and because of this, abortion is absolutely not
625	acceptable. What happens to the soul of the child? It returns to
626	its realm; whatever state, spiritual state, it came from. The
627	mother who permits such an action becomes responsible for depriving
628	that entity from its manifestation in the material world. That
629	soul becomes responsible then for the denial of the accomplishment
630	of perfection for that soul. Now, even if that soul had not
631	reached its perfection, the mother or the soul of that female body
632	becomes completely responsible for the loss of perfection for that
633	entity; she becomes responsible. Her soul has no way of telling
634	whether that soul would have reached perfection in that lifetime or
635	not; in that respect then she becomes responsible for the
636	destruction of an accomplished being; she becomes responsible for,
637	shall we say, the hindrance of a deity. As far as her own
638	spiritual state, she develops, shall we say, an extreme case of
639	self-centeredness. She is held responsible for self-love to the
640	degree that she is willing to end a whole new creation only to
641	serve her own self-seeking pleasures. So then she becomes

642 responsible for that entity's entire life, all the individuals that 643 that entity may have helped in his lifetime or her lifetime, all 644 the children that he may or she may have had, and all the 645 children's children and so on and so forth. Do you understand? 646 647 ***: Yes, thank you. 648 649 C: Abortion is not something to be taken lightly, but because of 650 the whole situation of the material manifestation now, one sin, 651 shall we say, piling upon another, one negative aspect upon 652 another, has made the material manifestation almost useless in the 653 soul's progression; so it is now fast reaching time when the 654 useless thing must be done away with, so that the soul can progress 655 beyond. Man speaks of these spiritual, shall we say, cycles, 656 spiritual evolutionary cycles, but he really does not listen to his 657 own words. He, shall we say, speaks very loudly of such great 658 spiritual things, yet when he makes them or brings them into his 659 being to become part of his, shall we say, affections or 660 intentions, he very promptly buries his head in the sand. The 661 entire debt that man, over the eons of time, the souls, have heaped 662 upon this whole cycle of evolution is so great that it is 663 overpowering; and so things are now in process to, shall we say, do 664 away with the obsolete; yet all things must be answered for, in one 665 way or another, to one degree or another. Very well. 666 667 ***: Does an aborted baby go to a realm to be born again? 668 669 C: There is no such thing as a baby in the spiritual realms. A 670 baby is merely a miniaturized tool or vessel for the soul or the 671 spirit. Its purpose or that form is to comply with nature so that 672 in this the soul then can form that tool and that container 673 according to the situation that will best serve the entity or the 674 spirit using that tool. After the, shall we say, child is aborted 675 or the fetus is aborted, the soul simply returns to the realm from 676 which it came.

713	***: In line with this, I would like to ask, maybe if there was a
714	problem with the mother's health or the baby's and there might have
715	to be a decision made, would the souls then be considered
716	differently in the after-life?
717	
718	C: Your question is not as clear as it should be. Can you
719	rephrase it?
720	
721	***: Say that in speaking, if the mother had a choice to abort
722	maybe because she did not want the baby, that would be one
723	situation, and her soul would be judged or would be considered in
724	one way; and then if there was a situation where a decision had to
725	be made as to whether the mother should live or the baby should
726	live, and she decided to abort the baby, would the soul then be
727	judged differently from that point of view or would she still be
728	responsible for that soul's development of perfection?
729	
730	C: In such, shall we say, a dilemma, if the physical situation is
731	such where the mother's life would be at stake if the child is
732	born, now saying that this is a true situation and not a
733	rationalization on any part of those people involved then it
734	would depend on the conscience factor, it would depend on the
735	conscience factor of the mother. If, in her understanding, if in
736	her place of spiritual awareness, she would deem her life more
737	valuable and would choose to have the child aborted, then she would
738	only be held responsible to the degree of her awareness. Do you
739	understand that?
740	
741	***: Yes, thank you.
742	
743	C: If then, she chose to give up her life for the child's sake,
744	the child would not be responsible for the mother's soul and its
745	death. Here we would show a great opportunity for a soul to
746	practice to the nth degree the Commandment of brotherly love. If a

747 mother finds herself in a position where her life is in jeopardy as 748 opposed to the birth of a new child, if she chose to give up her 749 life so that this new life may enter, she would fulfill all the 750 Commandments and thus in that action obtain perfection. She would automatically be removed from those realms that necessitate 751 752 reincarnation and would automatically move into the God-made 753 realms. 649	would you react? Now, we use that example to state the situation
650	of abortion. If there is a soul present in that unborn fetus, it
651	will experience death. It is that simple. Anyone in the medical
652	profession will tell you that the first thing to really develop in
653	the fetus is the brain. Some say it is primitive and will recoil
654	only in a manner that animals recoil. We say nonsense. There is
655	nothing about the human being that is pure animal, and from the
656	moment of conception to the moment of death even though you may
657	react in such a way to protect yourself that some observers could
658	say is animalistic or animal in nature, it is still basically the
659	soul's desire to continue to experience life. So, if the soul is
660	present or the entity, the spirit, is present in the fetus, then
661	whenever that fetus is destroyed that soul will experience a death

665	
666	C: As we have said before, abortion should never be considered

668	present previous to conception or it can be present at any time

670	know. There is not a psychic on the face of the earth that could
671	tell you when a soul is actually occupying that vibratory range
672	that the body manifests in. So, therein lies the problem with

680	let's call it the Devil or whatever term you want to

682	C: Well, you are aware of our opinions of the "Devil"?
683	

684 ***: I am trying to give the forces a name. 685 686 C: It is a self-centered attitude, a self-serving attitude of some 687 entities on the spiritual side. To say that someone is evil, 688 rarely do you find a soul or an entity that is evil. What you find 689 are degrees of self-centeredness, and there are entities on the 690 other side, in the Man-Made Heavenly Realms, that are so self-691 indulgent that they are literally hampering their own growth, and 692 in doing so they are utilizing or leaching off of the growth of 693 others. They are, how shall we put it, enticing others to come to 694 their way of thinking so that they are self-glorified. In other 695 words, they are using others to glorify themselves ... (Do you 696 understand?) 697 698 ***: Yes. 699 700 C: ... into perverted concepts, and they definitely have an 701 influence on the material. As these souls find avenues of entrance 702 into the material manifestation, this self-centeredness is very 703 apparent in their life, and they are strong enough in their self-704 centeredness to gain positions in your life and manipulate. Look 705 at this destruction of womanhood. LOOK at the destruction of 706 womanhood. You have women trying to act like men. Nonsense, 707 nonsense. They are abdicating their power, their position, by 708 trying to take over a man's situation. Silly, silly. They have 709 the control of the material world in their fingertips. 710 What they should do is liberate men. Men are the ones who 711 need liberating. They have been locked up into a small cell of 712 activity so that they experience very little growth, very little 713 awareness, and if the woman really wants power, if she still is not 714 aware of the power she has over the material manifestation, let her 715 unlock the male from his cast iron mold, and she will realize even 716 greater power than a simple job that should be done by a man or a 717 lifestyle that is more appropriate for the masculine. But then, of 718 course, this gets into the androgynous soul which eventually, if

719	you have the right questions, we will get into that too, but it is
720	not the woman that needs liberated in your society, it is the male.
721	It is the women who are more spiritual. Why? Because they are
722	liberated.
723	The more unliberated you are, the less spiritual you are, and
724	we cannot say that the male aspect is very spiritual. Take a look
725	at this room. In most organizations that you go to, whether they

728	The more strength and power you have, the more knowledge you have.

731	liberated. Their constraints cause them to die earlier in life.
732	Women, who are freer, who have the power, live longer.
733	Shouldn't that tell you something? And see what is happening in
734	your society today. Those women who lock themselves up in the
735	cages of men are beginning to die as early as men, they are
736	beginning to suffer from the same constraints that the male does.
737	The glory of life, the ultimate achievement in life, can be
738	reached easily by the female. That is why we have always spoken
739	highly of the female because in her lies the spirituality of
740	humankind, the spirituality of the future. If women exercised
741	their full potential in the family and in their positions, man
742	would never, never, never have another war. Very well.
